1. Introduction

These Terms and Conditions govern your use of services provided by **Fox Hill Consultancy** (“we”, “us”, or “our”). By engaging with our services, you agree to these terms. 2. Services We Provide

We offer a range of professional services, including:

- Executive and leadership coaching
- Corporate coaching cohorts and group sessions

- Away days and team-building facilitation

3. Booking and Agreements

All services must be confirmed in writing (usually by email or contact form). This agreement may outline:

- Session numbers and frequency
- Delivery mode (virtual or face to face)
- Location (if in-person)
- Fees, discounts, or pro bono terms

- Cancellation and rescheduling rules

4. Fees and Payment

Fees will be agreed in advance. Standard terms:

All fees are currently VAT-exempt. If VAT becomes applicable, clients will be notified in writing.

5. Cancellation and Rescheduling

Individuals:

- More than 48 hours’ notice: rescheduling without charge
- Less than 48 hours: session may be charged in full

Corporate clients:

- Cancellations require 7 days’ notice

- Less than 7 days: 50% of agreed fee may be charged unless rescheduled

We approach all cancellations with fairness and compassion while protecting time for both parties.

6. Confidentiality

All client information is treated as confidential unless:

- You provide explicit consent to share
- Disclosure is required by law (e.g. safeguarding concerns, criminal activity)

For corporate group work, thematic insights may be shared with commissioning clients only in an aggregated, non-identifiable way unless otherwise agreed.

7. Ethical Practice

Fox Hill Consultancy adheres to the **AOEC (Association for Executive Coaching) Code of Practice**, which includes:

- Respect for client autonomy
- Commitment to confidentiality and professionalism
- Ongoing reflective practice and supervision
